
OFFICE MEMO

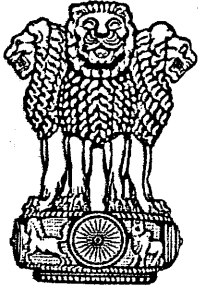

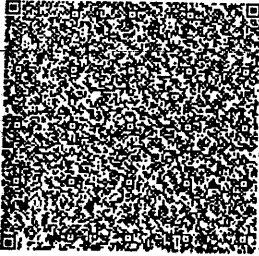

Whereas, the Party of the First Part is a "not for profit" apex organization, established by the Planning Commission of India (Now NITI Aayog) and the Indian construction industry with an objective to improve the functioning of Indian Construction Industry, including setting up of several institutions to enable Indian Construction Industry to achieve international standards.

Whereas, the Party of the Second Part which is a State Government Organisation

The parties of the First and Second Part have decided to collaborate, cooperate and complement each other to undertake initiatives and programs geared to the development of the state in various sectors through suitable interventions and have, therefore, decided to enter into this MOC.

The elements of this MOC are detailed as under:-

1. (a) Obligations of the First Party

- To provide the advisory services in the context of programs envisaged by the Second Party in various sectors.
- To provide the conceptualization to implementation stage services for the projects to be implemented in the State, as per requirements of the Second Party.



b) Obligations of the Second Party

- To identify the services to be provided by the First Party.
- To provide necessary facilitation to the First Party to discharge their obligation.
- To provide necessary resource based support and infrastructure to implement and execute the work under this.

2. The validity of this MOC shall be 5 yrs from the date of entering into this MOC, unless it is amended or terminated earlier.

3. Both parties hereby represent and warrant each other that:

- a) Both parties shall appoint one Nodal Person for seamless operationalization of this MOC. In case of any change in the Nodal Persons in either organization, the other party will be informed of the new contract person and there should be a handover process so that the new person can settle into the role. It is the responsibility of these Nodal Persons to:
- i. Work collaboratively to arrange meetings and reviews.
 - ii. Oversee any milestone reporting requirements as agreed by both parties.
 - iii. Keep both parties fully informed.
 - iv. Act as a first point of reference between parties and also as liaison persons for external contacts.
 - v. Communicate between parties on matters that arise that may be of interest to either party.





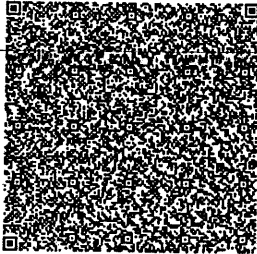

Public Works Department, representing **Government of Tripura**. Hereinafter referred to as the Party of the **Second Part**.


