For Section 82,84,85,86,87,88,89 & 90 of the Tripura Police Act, 2007', fine to be imposed is **Rs.200/-** (Rupees two hundred only) per offence/case.

Tripura Gambling Act

- For Section 12 of Tripura Gambling Act, fine to be imposed is **Rs.50** (Rupees fifty only).
- (ii) For Section 13 of Tripura Gambling Act, fine to be imposed is **Rs.200/-** (Rupees two hundred only).
- (iii) For Section 14 of Tripura Gambling Act, fine to be imposed is **Rs.300/-** (Rupees three hundred only).
- (iv) For Section 16 of Tripura Gambling Act, fine to be imposed for repeat of offences/habitual offenders is as under:
 - (a) For Section 12 of Tripura Gambling Act, fine to be imposed is **Rs.100/-** (Rupees one hundred only).
 - (b) For Section 13 of Tripura Gambling Act, fine to be imposed is **Rs.400/-** (Rupees four hundred only).

) For Section 14 of Tripura Gambling Act, fine to be imposed is **Rs.600/-** (Rupees six hundred only).

The aforesaid penal amounts are prescribed only in the interest to curb offences which shall not affect the revenue generation of the State.

The APPs of concerned Courts/ Stations are authorized to compound such other petty offence(s)/case(s) and/ or Criminal compoundable cases under any other Acts as may be taken up for disposal in Special Lok Adalats, on behalf of the State.

This shall come into effect immediately and be published in the official Gazette.
