MINUTES OF REVIEW MEETING CHAIRED BY THE SECRETARY, PWD, GOVERMENT OF TRIPURA ON 11-04-2023 IN THE CONFERENCE HALL NO. III OF SECRETARIAT, AGARTALA

A review meeting was held on 11-04-2023 at 4.30 PM in the Conference Hall-III of the Secretariat under the Chairmanship of Secretary, PWD, Government of Tripura to review the status / progress of road & bridge projects sanctioned under RIDF & Special Assistance to State. The list of officials present in the meeting is annexed (Annexure-A).

- 2. Present status of the ongoing and new works sanctioned under RIDF & Special Assistance to State has been briefed to the Chair through a power point presentation (PPT).
- 3. After detailed discussions, the following decisions were taken:
- i) Balance work tender for the work "Construction of Steel Bridge over Abhyacherra on Barpathari to Tulamura road at Ch: 4.50" shall be finalised at the earliest so as to finalise the gap funding to complete the bridge and also to take appropriate action to recover the difference of cost from the original contractor since the original work was rescinded at the risk & cost of the said contractor.

ii) Efforts shall be taken for earliest finalisation of tender received on 13th call of tender for the work "RCC bridge on the road from Dasda Bazar to Adibasighta at ch.1.20 km over Deo river" since construction of the bridge is important as it is located at the approach of the road from 'Buraighat to Shermun-II' which is likely to be sanctioned under NESIDS (Roads).

iii) Target for completion of all the ongoing bridges & roads committed by all the SEs/EEs shall strictly be ensured as mentioned below;

Slow progress of works due to poor performance of the contractor shall be dealt with strictly as per relevant terms & conditions stipulated in the agreement to avoid any delay in implementation of the works. Such slow progress / poor performance shall be recorded and appropriate action shall be processed in time against the concerned contractor as per relevant clause(s) stipulated in the relevant agreement.

(Action by: All SEs & EEs)

v) The fund released for the projects sanctioned under Special Assistance to State shall be utilised with the same financial year during which it was released to avoid reduction of allocation of fund under Special Assistance to the State during subsequent financial year by the Government of India.

(Action by: All SEs & EEs)

vi) The concerned Executive Engineers shall furnish 'Project Completion Report (PCR) immediate after completion of the project sanctioned under RIDF of NABARD. Further, it is mandatory to display Project Sign Board as prescribed by the NABARD for the entire project sanctioned under RIDF. Hence, display of the Project Sign Board for the RIDF projects if any pending shall be completed by 30th April, 2023.

vii) The Executive Engineers shall ensure that photographs of all development works shall be taken prior to commencement, during different stages of execution / progress and after completion and these photographs shall properly be preserved for records and references.

(Action by: All EEs)

viii) Detailed Project Reports (DPR) for road & bridge projects shall be prepared and kept ready for submission for funding under Special Assistance to State / RIDF of NABARD during current F.Y. 2023-24. While framing the DPRs, the projects shall be prioritised according to the importance as per actual field needs in consultation with the local PRI bodies / Public representatives.

(Action by: All the SEs & EEs)

ix) New Technology shall be explored / adopted in order to promote cost-effective and fast construction technologies in the construction / strengthening & improvement of roads. While framing the DPRs for construction / strengthening & improvement of roads, necessary provisions of new technologies shall be kept as per actual field feasibility.

(Action by: ACE (P&D Unit), All SE & EEs)

Workshop on new technologies in the construction / strengthening & improvement of roads shall be organised in presence of the field engineers of PWD with the assistance of NIT, Agartala within May, 2023.

(Action by: DS-II, PWD(R&B))

Xi) Quality is the prime concern of development works. Frequent field inspections shall be carried out by all concerned engineers to ensure the quality of works. Necessary testing of the construction materials shall be carried out conforming to the relevant BIS codes prior to use and intended workmanship shall also be ensured to achieve the desired quality of the works.

Punctuality in duties is the prime concern for all government employees. The concerned Head of Offices / DDOs shall maintain a movement register in their receptive offices regarding movement of the employee(s) to perform official assignments outside the office(s). Such records of movement of the employee(s) shall be presented before the higher authorities as & when asked for.

xiii) In case, the contractor completes the work ahead of stipulated date of completion, an incentive may be paid to the concerned contractor as per provisions stipulated in the relevant agreement.

xiv) All ongoing projects sanctioned under Special Assistance to State for Capital Investment, 2022-23 and RIDF-XXVIII shall be completed within the stipulated time frame as per work orders.
