Notification

In exercise of the powers conferred under Section 2 of the Epidemic Disease Act, 1897, the State Government is pleased to make the following regulations to amend "The Epidemic Disease, COVID 19 Regulations, 2020."

1. Short Title & Commencement:-

- (i) These regulations may be called "The Tripura Epidemic Disease, COVID-19 (4th Amendment) Regulations, 2020."
- (ii) These regulations shall come into force immediately and shall remain valid until further order.

2. Amendment of Regulation 2(iii) :-

In Regulation 2(iii), "as well as officers of district administration not below the rank of deputy collectors and police officers not below the rank of Sub-Inspector" will be added after Health and Family Welfare Department.

3. Insertion of Regulation 10A after Regulation 10 :-

10A. If a suspected person of COVID-19 refuses to provide swab or blood sample or non-cooperates with the health workers, the officers authorized in section 2(iii) of these regulations will have powers to forcefully collect the sample and secure assistance from police or members of society for this purpose.

10B. The institutional quarantine centres, isolation centres, covid care centres, dedicated covid health centres and dedicated covid hospitals will be treated as restricted areas. Any unauthorized entry/exit to/from these restricted areas including any attempt to escape by patients or suspected persons will be a punishable offence. Any disorderly behaviour and act of violence, misbehaviour or misdemeanor and attempt thereof by the inmates and staffs of the centres will also be punishable. The officers authorized in section 2(iii) of these regulations will have powers to take requisite measures to restore order in the centre.

In Regulation 13, the words "Regulation 10, 10A, 10B" will be added after "Regulation 8" for imposing fine of Rs. 1000/-.




