NOTIFICATION

The Governor of Tripura on being pleased has ordered to reorganization of Public Works Department (Drinking Water and Sanitation), at State Headquarters and empower to some Block and GP/VC level officials, for attachment of more focus on implementation of Swachh Bharat Mission (Grameen) [SBM(G)] Phase-II programme in rural areas of State of Tripura by 2024-25 and the reorganization shall be on the following manner:

- The Chief Engineer, PWD(DWS) shall be relieved from implementation of SBM(G) Phase-II rather to focus on ambitious target of 100 percent saturation of rural household, School and AWC etc. with Functional Household Tap Connection (FHTC) by 31st December, 2023.
- The Director, WSSO, PWD(DWS) shall be involved in full to concentrate on the implementation in respect of program and support activities of SBM(G) Phase-II to accomplish 100% ODF plus model villages in Tripura under immediate administrative control of the Mission Director, SBM(G), Government of Tripura for SBM(G) Phase-II programme.
- Additional manpower shall be deployed from available staff strength of PWD for strengthening of existing manpower in the office of the Director, WSSO as stated hereunder:
 - ✓ Executive Engineer (for Planning & Design): 1 No.
 - ✓ Finance Controller: 1 No.
 - ✓ Accountant: 1 No.
 - ✓ Cashier: 1 no.
 - ✓ LD clerk: 1 no.
 - ✓ Group D staff: 1 No.
- The senior most official by designation among Panchayat Officer/Panchayat Extension Officer/Panchayat Supervisor will function as Block Coordinator for the purpose SBM(G) programme in each RD Block.
- Rural Programme Manager at GP/VC level will act as Village Coordinator for SBM(G) programme as additional duty in each GP/VC.



- The Member Secretary, District Swachh Bharat Mission Management Committee (DSBMMC) in each District will be under direct administrative control of Director, WSSO for implementation of SBM(G). The establishment matter relating to the Member Secretary, DSBMMC will continue to be under control of the Chief Engineer, PWD(DWS).
