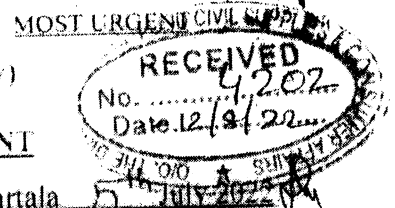

MEMORANDUM

Subject- Discontinuance of special increment as incentive in the form of personal pay for adoption of small family norms w.e.f. 01-04-2021.-

The undersigned is directed to refer to the Finance Department, Government of Tripura vide letter No. F.7(4)-FIN(ESTT.BR.-II)/2021/1736, dated the 28th January 2021 regarding discontinuance of special increment as incentive in the form of personal pay for adoption of small family norms w.e.f. 01-04-2021 on account of discontinuation of the same in Central Government vide O.M.No.F.12(4):2016-EIIIA dated 7th July 2017 of the Department of Expenditure, Ministry of Finance, Government of India wherein the allowance for adoption of small family norms has been ceased to exist in all cases.

Therefore, keeping in view of the Government in Finance Department, the Health & Family Welfare, Government of Tripura has decided to withdraw the Memorandum No.F.4(130)-SFPB/77-78/79-84 dated 12-11-1986 regarding "Introduction of incentive among State Government employees for promoting small family norms" w.e.f.1st April 2021; and accordingly no incentive for adopting small family norms shall be admissible to the State Govt. employees from 01-04-2021, including to those who had been in receipt of the incentive prior to 01-04-2021.

This is issued as per approval of the competent authority vide U.O.No.23 dated 16/07/2022 Office of the Secretary Health, Health and Family Welfare Department, Government of Tripura.
