**M E M O R A N D U M**

**Whereas,** M/S Narmada Rn. Das & Co., Rajbari, Dharmanagar was enlisted under PWD, Government of Tripura as Class-I (i.e qualified to tender for works costing upto any amount) vide letter No.F.8(11)-PWD(C)/91 dated 17.12.1991 with partners i). Sri Narmada Rn. Das, ii). Sri Chandan Das and iii). Sri Nandan Das.

**AND**

**Whereas,** Sri Narmada Rn. Das expired on 2<sup>nd</sup> October 1998. The matter was concealed and not informed to the department and the said firm executed works under PWD upto 2016.

**. AND**

**Whereas,** during the revalidation process on Sep, 2016, a deed of partnership and General Power of Attorney was submitted and it was observed that Sri Narmada Rn. Das, P/A of the said firm was dead and new partner namely Sri Shibendu Das, S/o Lt. Narmada Rn. Das was incorporated in the firm and Sri Chandan Das was made P/A by Sri Nandan Das & Sri Shibendu Das.

**AND**

**Whereas,** Sri Nandan Das one of the partner of the firm expired on 20.06.2017. But the partners of the firm neither approached nor intimated to the department about death of another partner viz Sri Nandan Das & the constituents of the firm became less than 50%.

**AND**

**Whereas,** it appears that Sri Chandan Das submitted the application for revalidation instead of authorised signatory & 2(two) other new partners was incorporated, who were not the original partners of the said firm and the application was forwarded vide letter No.F.41(105)/SE(1)/913-14 dated 04.08.2021 of the Superintending Engineer, 1<sup>st</sup> Circle, PWD(R&B), Kumarghat. The said firm executed works under PWD during the intervening period.



Now, therefore, it is imperative that the agency violated the provisions of Enlistment Rules of PWD, Tripura in regards to incorporation of new members as well as concealed the fact to the Department & since the constituents of firm reduces to the 50% on death of 2(two) partners, the enlistment of the firm shall be considered to be ceased as per stipution of Rule 14 & Rule 14.3 of Rules for Enlistment of Contractors in PWD, Tripura 2020.
