SE 1 <sup>st</sup> Circle,PWD(R&B) for Unakoti & North District.<br>2. SE 2 <sup>nd</sup> Circle,PWD(R&B) for West & Khowai District.<br>3. SE 3 <sup>rd</sup> Circle,PWD(R&B)for Gomati & South District.<br>4. SE 4 <sup>th</sup> Circle,PWD(R&B) for Sepahijala District.<br>5. SE 5 <sup>th</sup> Circle,PWD(R&B) for Dhalai District. |

| <b>Validity of enlistment.</b><br>The enlistment shall be valid for a period of 5(Five) years from the date of issue. (Ref:- PWD Works Manual- Rule-7 of Enlistment Rule-2007.   | <b>Validity of enlistment.</b><br>The validity of all the enlistments in all categories issued time to time are hereby <b>extended upto 31.12.2014</b> unless otherwise specified.  |
