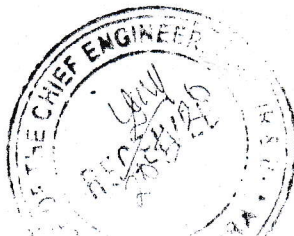
Now, it is decided that the security personnel, if deployed in any Government/PSU Offices or Government Institutions, should not allow entry to any person who are not wearing face cover/mask.

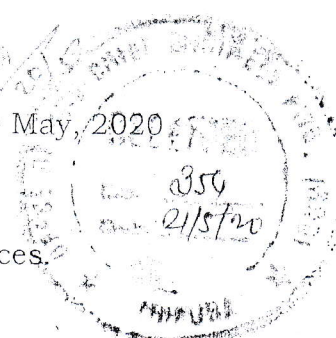
